1. Costs include VAT where applicable
2. Remuneration and relevant allowances were subject to Income Tax and National Insurance.
3. Costs met directly by the Council for the use of a council officer driven car up to 18/07/2023 and pool cars from 19/07/2023 to 31/03/2024 have been noted for financial year 2023/24. An average mileage rate of £0.18 has been identified for vehicles used. Staff costs associated with driving these vehicles have been estimated at an average of £20.67 per hour in addition to mileage costs.
4. Travel and subsistence expenses, where claimed, relate only to the reimbursement of actual expenditure incurred by the Councillor. Reimbursement of expenses for overseas trips is included in the travel and subsistence columns. Overseas trips for 2023/2024 equated to £727.02
5. Accommodation expenses are met by the Council. Councillor Ahern paid for accommodation upfront therefore this had to be reimbursed through payroll.
6. Telephone and ICT Expenses - Support costs are met by the Council. These costs have not been claimed by the elected member.
7. As prescribed in the Regulations receipted expenditure up to a maximum of £3,000 per annum can be reimbursed to the Provost, or any other member deputising for the Provost in carrying out his/her civic duties. No payments were made in financial year 2023/24.
8. The total value quoted per elected member includes direct costs met by the Council. Direct costs have not been claimed by the elected member.
9. The format of this report follows that prescribed in the Scottish Government's publication titled 'Councillors' Remuneration: Remuneration, Allowances and Expenses - Guidance (Revised April 2010)' to ensure consistency of interpretation between all Scottish Local Authorities.
